<u>Charges</u>

Eligible Children are entitled to <u>30 hours per week</u> Government Funded sessions.

A charge of ± 15.00 per week will be required on a Monday for the lunch time provision whilst using this entitlement (8.30am - 3.30pm). Please note that your ± 15.00 per week is non-refundable and it will still be paid in the event that your child is off Nursery (excluding half-term and bank holidays).

Morning Session8:30am - 11:30amLunchtime (Packed Lunch Required)11:30am - 12:30pm £3.00 per dayAfternoon Session12:30pm - 3:30pm

- Fees must be paid on a Monday of each week for <u>all</u> 30 Hour provision.
- You need to provide your child with a packed lunch <u>daily</u> if you are using the lunch time provision.
- If you do <u>NOT</u> want lunch time provision for your child you must collect your child at 11.30am and return your child at 12.30pm for the afternoon session.
- Children will <u>NOT</u> be able to stay in this provision if you do not provide a valid code, validate it every three months and payment is not received.
- Late payments may result in losing your lunchtime place.

Charges:

• Parents who are late to collect their child will be charged £5:00 for each 15mins to cover increased staffing costs.
